CONSULTING EXCELLENCE SUSTAINABILITY

We recognise the importance of both environmental protection and sustainability. Hence, we are fully supportive of the NHS's Net Zero targets and wider sustainability initiatives.

We are committed to achieving net zero emissions by 2040. We have developed a number of initiatives within our office and as part of our business operations to minimise environmental impact

We are working towards achieving ISO14001 by November 2024; the internationally recognised standard for environmental management systems (EMS)

Internal training and expertise ensures our team are well-placed to understand the legal, societal, and economic case for increasing sustainability, and how we can translate sustainability to actionable, measurable outputs for our clients

We use an external, certified organisation to accurately measure our emissions in line with GHG Protocols and Science Based Targets across Scope 1, 2 and 3







When working with our clients, we ensure that sustainability, as a core element of social value, is appropriately considered in the design and implementation of our projects.

Akeso have developed a 5-step methodology to effectively support organisations in identifying, appraising, and measuring the key question of "will the project deliver tangible benefit to patients and the community it serves to enable them to live healthier, happier lives?"

Akeso publish an annual Carbon Reduction Plan. In the most recent edition, we outlined our 2023 Principal Environmental and Sustainability Objectives:

- 1. To understand the impact that our own and our supplier's actions have on the environment
- To take all reasonable and practical measures to reduce our own and our suppliers' impact on the environment as a result of carrying out business
- 3. To publicise and promote the impact that changes in ways of working have can have on the environment and measures of sustainability
